Kõigile, keda see puudutab ning nende õigusjärglastele:

Selle kirja saadame Meie, Terra Esthia Elavad Mehed ja Naised, kes elame sellel Maa-alal, mida me kutsume Terra Esthiaks [üldtuntud kui Eesti või Eestimaa] kui ka Terra Esthia saared, mis on taas Maa ja Pinnase Jurisdiktsioonis ning selle kirjaga on kaasas "Avalik Teade" Terra Esthia Rahvakogu taastamisest. Meie nõuame viivitamatult igasuguse sõjategevuse ettevalmistamise lõpetamist, sõja informatsiooni jagamist ning sellega seoses keelame kaubandusliku sõja pakkumiste ja teavitamiste edastamise igasuguste privaatsete ja avalike allikate kaudu sinsele Rahvale.

Teie, kes esindate korporatsioone, mis on munitsipaal-, kiriklikul-, admiraliteedi-, mere- ehk kaubandusjurisdiktsioonis ning püüate Elavatele Hingedele tekitada kahju oma kaubanduslike konfliktidega, mida kutsute "sõjaks", kuid mis seda tegelikult ei ole, on aktsepeerimatu, vastuvõetamatu ja läheb vastuollu Meie vaba tahtega.

Teie ülesanne on lahendada korporatsioonide vahelised konfliktid nii, et Meie ja Meie vara, Maa ja Pinnas jäävad kahjustamata. Meil, Elavatel Meestel ja Naistel, ei ole mingit pistmist teie korporatsioonide vaheliste konfliktidega, seega on teie kohus ehk "Usufruct Duty"- kasutusvalduse kohustus, hoida Meid ja Meie vara kahjustamata nagu on kehtestatud Haagi konventsiooniga. Meie, Elavad Mehed ja Naised, oleme rahumeelsed ja elame rahu ning soovime ka edaspidi elada üksnes rahumeelselt Terra Esthia Maal ja Pinnasel. Kui Meie rahu rikutakse ning Meid ja Meie vara kahjustatakse, siis on kahju tekitanud ametniku kohustus tasuda igale Elavale Hingele siinmail 9000 tonni väärtuses .999 sertifitseeritud puhast hõbedat ning peate loovutama oma vereliinidest samas väärtuses Hingi, kui palju Hingi kaotasid Terra Esthia Maa-alal Elavad Mehed ja Naised.

Me ütleme, et Meie ja Meie Esi-esivanemad, kes on selle Maa pärismaalased, ei ole kunagi lubanud muuta sünnijärgse õiguse staatust Meil, kes oleme ilmale tulnud Maa ja Pinnase rahumeelsel Terra Esthia Maa-alal [tuntud kui Eestimaa].

Absurdne on väita, et oleme võitlejad mingiski sõjas, riigi vaenlased või allume mis tahes välisriigi sõjaseadusele. Kui Meie sünniõiguslikku staatust on muudetud mõne sõdiva riigi või korporatsiooni esindaja poolt, siis on see tõestus 1949. aasta Genfi konventsiooni protokollide rikkumisest, II köide, artikkel 3. See on tõendus (prima facie evidence) kõige kõrgema karistusega kuriteo kohta, mis on toime pandud Rahvusvahelise Valuutafondi/IMF ja Ameerika Ühendriikide/UNITED STATES, ÜRO, NATO, EUROOPA LIIDU/Euroopa Liidu ning Eesti Vabariigi ametnike ja nende frantsiiside poolt sõjaseisukorra alusel.

Meil, Elavatel Meestel ja Naistel, on sünnipärane õigus Terra Esthia Rahvuslastena elada sellel Maa-alal täieõiguslikult ja rahu hallata seda Maad.

Usaldus nõuab **hoolitsust**. See põlvkond ei tohi hävitada, mida ta on järgmisele võlgu. Igäihe kohustus on anda usaldus edasi samas või paremas olukorras, kui ta selle sai.

Me ütleme, et ei ole andnud volitusi kasutada Meie nimesid või Meie krediiti või mis- tahes Meie Maaomandis olevat vara käenduseks mistahes valitsemisteenuste korporatsiooni võlgade katteks ja ei ole valinud pooli ega osalenud üheski sõjas, ei tunnusta mingeid vallutusõigusi, mis puudutab Meid ja Meie vara. Mitte ühelgi ettevõttel Maal ei ole volitusi sõja kuulutamiseks ja seetõttu ei ole tal ka mingit legitiimset nõuet sõjaseaduse ja Rahvaste õiguse suhtes. "FALSUS-IN-UNO-FALSUS-IN-OMNIBUS"

Meie, Terra Esthia Elavad Mehed ja Naised, keelame Terra Esthia Maal ja Pinnasel meie Rahvast kahjustavad tegevused, esmajärjekorras järgnevad tegevused:

- Fosforiidi ja uraani kaevandamise;
- Sõja propageerimise ja muude hirmutamistehnikate kasutamise mistahes viisil, kaasa arvatud kaubanduskonfliktid palgasõdurite armeed kasutades. Peatada kõik militaarobjektide rajamised Terra Esthia pinnale ning taastada Nursipalu looduskeskkond militaarobjektide täieliku kõrvaldamisega;
- Tuuleturbiinide püstitamise ja kasutamise või kuidas iganes te neid nimetate ning nende jäätmete ladustamise ja matmise;
- Päikesepargid või kuidas iganes te neid nimetate ja nende jäätmete ladustamise ning matmise ;
- Kaugloetavate „Smartmeter“ elektriarvestite kasutamise;
- 5G ja kõrgema sagedusala kasutamise vms;
- Mobiilsatelliitsidejaamade rajamise ja kasutamise või kuidas iganes te neid nimetate (näiteks: Ameerika Ühendriikide satelliidifirma Globalstar maajaam Kilingi-Nõmmes);
- Ilma mõjutamise ja seire inimest kahjustava tehnoloogiaga, muu hulgas: „chemtrails“, HAARP, ilmaradar, nanografeeni pihustamine ning selle nime ja teema teised variatsioonid, kõik katsed mõjutada õhuniiskuse ja päikesevalguse loomulikku toimimist;
- Laskemoonatehaste ja sellega seotud ladude rajamise ja kasutamise või kuidas iganes te neid nimetate ja nende jäätmete ladustamise ning matmise;
- Kõrgepingeliinide, mis on suuremad kui 110 kV, rajamise ja kasutamise;
- Rail Balticu rajamise ja kasutamise;
- Joogivee töötlemise fluoriidiga;
- Pestitsiidide, taimekaitsevahendite, väetiste ja muude loodust ja põhjavett reostavate kemikaalide kasutamise;
- Rasketehnika kasutamise metsaraietel ja metsa lageraied ja teised selle nimetuse variatsioonid;
- Pandeemiate korraldamise ning muude viiruste ja haiguste tahtliku tekitamise ja edastamise, samuti valediagnoosidel põhineva teabe koostamise ja levitamise;
- Kohustusliku ja sundusliku vaktsineerimise;
- Nanografeeni ja muude ohtlike lisainete lisamise toitu (E621, E951 jne) seal hulgas putukate, ritsikate, inimese DNA lisamise jt;
- Inimkaubanduse ja organidoonorluse (ning adrenochrome).

Antud teod on kaubanduslikud ja rahvusvahelised inimsusevastased kuriteod, mille eest karistatakse Tavaseaduse Vandekohtus.

Eelpool loetletud punktides juba olemasolevad rajatised tuleb mõistliku ajajooksul likvideerida. Me peame mõistlikuks ajaks 2-5 aastat (kõrepingeliinide, tuulikute ja suuremate ehitiste/seadeldiste puhul 5 aastat, muud punktid 2 aastat). Piisavatel põhjendustel oleme vajadusel mõne toimuva tähtaja pikendamiseks valmis sõlmima kokkuleppe. Tähtaja lõpp on 7538 T.T.R.S.[ juuni 2030].

Me keelame Rahvast kahjustavad tuulepargid, päikesepargid, tuumajaamad, kõrgepingeliinid, mis on suuremad kui 110 kV ja seega nõuame teilt, kui teenusepakkuvalt vabaenergia tehnoloogia kättesaadavust Rahvale.

Teavitame teid, et 2013 aastal andis Vatikanis Paavst FRANCISCUS välja "APOSTOLIC LETTER, ISSUED *MOTU PROPRIO*, OF THE SUPREME PONTIFF FRANCIS, ON THE JURISDICTION OF JUDICIAL AUTHORITIES OF VATICAN CITY STATE IN CRIMINAL MATTERS", millega eemaldas kõigi ametnike puutumatuse ja sellest ajast vastutavad kõik ametnikud isiklikult.

„Amet“ ja „autoriteet“, mida nad väidavad endal olema ning vorm, mida nad võivad kanda, ei kaitse neid mingil moel, kujul või vormis- "QUI-FACIT-PER-ALIUM-FACIT-PER-SE". Tutvuge Nürnbergi protsessi ja Genfi konventsiooniga seotud dokumentidega antud kontekstis, millele enamik riike ka Eesti Vabariik 1992. aastal on alla kirjutanud.

Selle "Avaliku Kohustusliku Vastutava Teate" kättesaamisega on igasugune eitamine kõrvaldatud - "JUS-ET-FRAUDEM-NUMQUAM-COHABITANT", "FRAUS-EST-CELARE-FRAUDEM", mis tähendab "Pettuse varjamine on pettus" ja kõik, kellele see kiri on adresseeritud, mõistavad vaikimisi, et need sõjakuriteod (mida teie juriidiliste seaduste kohaselt käsitletakse sõjakuridegudena) tuleb avalikult välja tuua. Seaduse Maksim (Maxim of Law) järgi "pettuse varjamine on pettus" ja pettusel ei ole aegumise tähtaega.

Kõik, kellele on see "Avalik Kohustuslik Vastutav Teade" adresseeritud, on nüüd vastutavad "Avaliku Kohustusliku Vastutava Teate" sisu ja täitmise eest.

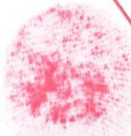

To whom it may concern and their heirs and successors:

We, the Living Men and Women on Terra Esthia, who live on this land, which we call Terra Esthia [commonly known as Estonia] and also the islands of Terra Esthia, which are once again under the jurisdiction of the Land and Soil, and the relevant paperwork "Public Notice" accompanying this letter. We demand the immediate cessation of all preparations for military action, the dissemination of military information, and in this regard, we prohibit the transmission of commercial military offers and notifications through any Private or Public sources to the People on the Land and Soil of Terra Esthia.

You, who represent corporations that are under municipal, ecclesiastical, admiralty or maritime commercial jurisdiction, and who seek to harm Living Souls with your commercial conflicts, which you call "war" but which are not actually a war, are unacceptable, and contrary to Our Free Will. Your task is to resolve conflicts between corporations in such a way that we and our property, the Land and the Soil, remain undamaged. We, the Living Men and Women, have nothing to do with the conflicts between your corporations, so it is your duty, "Usufruct Duty," to hold us and our property unharmed, as established by the Hague Convention. We, the Living Men and Women, are peaceable and live in peace, and we choose to continue living peacefully on Terra Esthia's Land and Soil. In case of a violation of our peace resulting in harm to us or our property, the official responsible shall be obliged to compensate each Living Soul here 9,000, nine thousand tons of .999 Certified pure silver, as well as equivalent in number to the Living Men and Women harmed on the Land of Terra Esthia, must be restored through the surrender of Living Souls from your bloodlines.

We say that We and Our Ancestors are Native People, born on this peaceable Land on Terra Esthia [known as Estonia], have never authorized any change of our birthright status. This is important because it demonstrates the absurdity of claiming that we are combatants in any kind of war, that we are enemies of any state, or subject to any foreign military law. If our birthright status has been changed by any nation at war, it is proof of violation of the Geneva Convention Protocols of 1949, Volume II, Article 3 and prima facie evidence of a capital crime having been committed by agents of the IMF and the UNITED STATES, UNITED NATIONS/ United nations, NATO, EUROPEAN UNION/European Union and Republic of Estonia and their franchises under color of martial law.

We, the Living Men and Women, have the inherent birthright as Terra Esthia Nationalists to live on this Land with Full Rights and to manage it in Peace.

The Trust requires **care taking**. This generation cannot destroy what is owed to the next. It is every adult's duty to hand over The Trust in the same or better condition than he received it.

We say that we never authorized anyone to offer us or our credit or any asset of our Private Estates as surety for the debts of any governmental services corporation whatsoever and we did not take any sides or participate in any war and we do not recognize any right of conquest related to us and our property. No corporation on Earth has Authority to declare war and therefore has no legitimate claim upon the Laws of War nor the Law of Nations. "FALSUS-IN-UNO-FALSUS-IN-OMNIBUS"

We, the Living Men and Women on Terra Esthia, prohibit any activities on the Land and Soil on Terra Esthia that harm our People, including all the following activities:

- Phosphorite and uranium mining;
- War advocacy and the use of other intimidation techniques by any means, including mercenary conflicts using mercenary armies. To stop all construction of military objects on Terra Esthia and to restore the natural environment of Nursipalu by the complete removal of military objects;
- Wind Turbines erection and use or whatever you call them and its waste stowing and matting;
- Solar park/solar farm/ photovoltaic park or whatever you call them and its waste stowing and matting ;
- The use of remotely readable "Smartmeter" or whatever you call them;
- Use of 5G and higher frequency bands, etc;
- The construction and operation of mobile satellite communication stations, or whatever you want to call them (for example: United States satellite company Globalstar ground station in the vicinity of Kilingi-Nõmme);

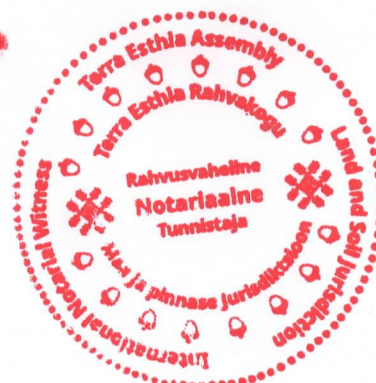
