We, the People, gathered on 5 Veilet 7533 T.T.R.S. [25 May 2025] on the Kauksi village center, Kauksi village, Põlva County at 12:00. We officially and solemnly declared the Terra Esthia Assembly on the Land and Soil Jurisdiction, which is not incorporated and which is for the People, by the People and of the People.

We publicly announced the day of the call into Session of the Terra Esthia Assembly 30 days before in various ways: on public notice boards in different areas [counties], in LõunaLeht [15 May 2025], Kagu Raadio, on social media - Telegram and Facebook.

We have Lawfully affirmated the Chairman of the Terra Esthia Assembly, Igor Laur(c); the Recording Secretary, Eneli Kreem(c); the Ombudsman, Aare Pohla(c).

The Terra Esthia Assembly is dedicated to restoration of a complete and fully operational Land and Soil Jurisdiction court system serving the People of Terra Esthia; preservation of the National Trust; the enforcement of the Public Law; the upholding of the Constitution owed to our Nation, People and the land of Terra Esthia; the repopulation of our Land and Soil Jurisdiction; the filling of vacanted Public Offices; and the reclamation of our material and intellectual public assets and Land Title. We do this peacefully and without rancor in the exercise of our unincorporated powers and capacities.

We restore the four pillars: the General Assembly, the Jural Assembly, the Peacekeeping (Militia) Assembly, and the International Business Assembly.

We have declared the Peace Flag of Terra Esthia, on the Land and Soil, which is recognised as a symbol of the authority of it's People, who have an ancient and undeniable heritage as a fundamental unit of governance. We are peaceable.



We have declared the Metes and Bounds of the Land of Terra Esthia. We call the Men and Women who live on the Land of Terra Esthia Aestids. We, the Living Men and Women, are Suveran and only Suverans can govern the Land. All the Land and Mineral Resources of Terra Esthia belong to the use of the Living Men and Women, which the Creator has given for the benevolent use of all who have a Soul, Spirit, Common Sense and a Clean Conscience. Lands may not be sold to corporations, Land may be given for the benevolent use without harming Nature and the People, and it is forbidden to demand taxes for Land and other property belonging to the Landholder.

We, Terra Esthia Nation, On the First Lawful day, no one had any objections/ rebuttals, therefore Terra Esthia Assembly Lawfully stands on the Land and Soil with the recognition of the People. We rely on Common Law, Natural Law, Nature Law, Creator's Law and the Knowledge of the Ancestors.
