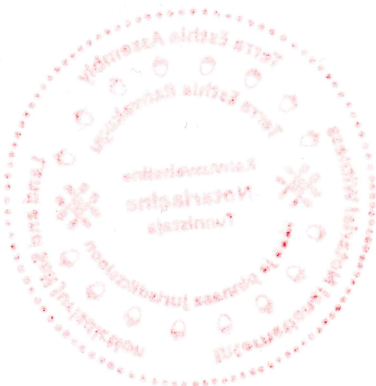

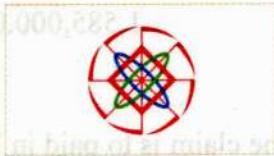

To whom it may concern:

First of all, my Business language is plain English in writings and may to choose speaking also in English. As a Officials you must understand English which is the International language. I do not live in Estonia. I live on Terra Esthia. I write as the Living Woman on the Land and Soil, and not as the corporate entity.

I had situation with Police Officers in Pärnu Town 01 mai 2025. Nelle Tõnning/NELLE TÖNNING wanted to force me to do alchol breath test and i did not consent. I told to Officers Nelle Tõnning/ NELLE TÖNNING and to Eivo Evertsoo/ EIVO EVERTSOO that i am Living Woman and i am on the Land and Soil Jurisdiction. They ignored my status as a Living Woman, Foreign Suveran. I gave them my paperwork: "Declaration of Esthian National Political Status" and "Witness Testimony Affirming Esthian National Political Status and Identity" two of them and Credential card. Eivo told that my paperwork is Pseudo documents and i am talk very stupid thing, basic laugh at me. He doesn't have Authority to tell that. He and Nelle Tõnning/ NELLE TÖNNING are unprofessional. In their positions, they are not allowed to have their own personal opinions or to make judgements, which they both did. I am not going to discribe all situation. I recorded and also Officer Nelle Tõnning/NELLE TÖNNING recorded. I have proof that Eivo Evertsoo/EIVO EVERTSOO and Nelle Tõnning/ NELLE TÖNNING impersonated me, violated with my rights, mocked me. I told many times

that i am not that passport what they found on your system. They ignored all what i told. Nelle Tõnning said that I have a passport issued by the Republic of Estonia and I am a citizen of the Republic of Estonia. Nelle Tõnning/ NELLE Tõnning, despite my explanations, forced me into slavery, which is a war crime.

I asked many times that have i harmed or made injury anyone? They could not prove that i made harm/injury to someone. Then there wasn't any case, "VÄÄRTEOPROTKOLL" is fraudulent and must be closed immediately.

Politsei- ja Piirivalveamet and Eesti Vabariik are corporations, whose revenues you are trying to earn. Nothing to do with me, i am Living Women on the Land and Soil Jurisdiction! There is no contract between me and the corporation. That is a fact!

Dear Secretary of State **Keit Kasemets/ KEIT KASEMETS** as well as his Heirs and Successors.

I have sent to you my paperwork (hereinafter 928 package). 13 Officials have received 928 package and "Notice of Acceptance, Mutually/Tacitly agreed War Crimes": **Villu Kõve/VILLU KÕVE, Jürgen Ligi/ JÜRGEN LIGI, Yoko Alender/ YOKO ALENDER, Hans Moks/ HANS MOKS, Piret Müür/ PIRET MÜÜR, Margus Tsahkna/ MARGUS TSAHKNA, Lauri Läänemets/ LAURI LÄÄNEMETS, Andres Parmas/ ANDRES PARMAS (Taavi Pern/TAAVI PERN), Liisa-Ly Pakosta/ LIISA-LY PAKOSTA, Signe Riisalo/ SIGNE RIISALO, Egert Belitšev/ EGERT BELITŠEV, Keit Kasemets/ KEIT KASEMETS, Alastair John Naisbitt King DL/ ALASTAIR JOHN NAISBITT KING DL (City of London).**

All Officials has been Tacit Agreed. An un rebutted affidavit becomes a judgement in commerce. Legal Maxim: "*He who does not deny, admits.*" I gave to all 30 days to rebutt, now my paperwork standing as a Law, fact. Now you have duty to hold me harmless- USUFRUCT DUTY. I am not RIINA TOOMELA (UCC) and Riina Toomela (UCMJ), never been. Your corporation made up franchises/vessels and made me believe it is me. I own both Copyrights and Trademarks to the vessels: Riina Toomela (UCMJ) and RIINA TOOMELA (UCC). This is fraud, theft, and criminal. The claim is void ab initio.

Any Officials or Officers are not allowed to use those Trade Names without my consent/permission. If corporation's employees want to use Trade Names which is named after me, then i have Fee Schedule what you all received. All 13 Officials duty is to hold me harmless and let to know other Officials and employees about my status- **Notice to Agents is Notice to Principals, and Notice to Principals is Notice to Agents.**

The Mantatory Notice from 928 package, is for your protection, which lets you know that you are dealing with Foreign Suveran.

All corporations are registered in Brad Street, United States of America. All Corporations registered there are subject to the UCC. This is the Commercial Code. You are doing business. I am not corporation or the employee in there. All rules, regulations, acts, codes etc are internal rules of procedure your corporation and do not apply to me.

If you are not aware of the fraud and saying: "I am just doing my job." this does not exempt from punishment. That all are criminal and i have made you aware of this .

Your Jurisdiction stands only in paper or in your computer. All things what are actuals and facutals belongs to Land and Soil Jurisdiction and for the People. Police Officers step in my Jurisdiction to standing on the Land with their two feet and holding in their hands my paperworks. By the way, this is Treason. Nelle Tõnning/ NELLE TÕNNING and Eivo Evertsoo/EIVO EVERTSOO hold my paperworks which described my status, they refused to return the paperwork which i given to them for inspection, while claiming that paperworks

were not valid documents. So by holding these documents in their possession, they accepted them and automatically went into the jurisdiction of the Land and Soil and they had a duty to protect me. They used my Lawful paperwork to move me to another jurisdiction. This is a war crime. Both Officers will receive a True Bill. If they are not going to pay, i will start the UCC Lien process. The UCC Lien will go publicly worldwide. It is not removable. All parties are now responsible for stopping the violation of my rights immediately.

Cestui que vie is French for "he who lives". It is a legal term for an individual who is the beneficiary of a trust or an insurance policy, with rights to property and the income and profits that the property provides.

I am not lost on the Sea and i am not dead person. I am Living Woman - beneficiary and i declared that i returned from the Sea to the Land. **That is an Unrebutted - Fact and stands as a Law!!!**
